## HOW DO I LEAVE A LEGACY?

The most popular ways to create a legacy with Action Against Hunger are through a gift in your will or by beneficiary designation.

### ADDITIONAL GIFT BENEFITS:

- Flexibility. These gifts give you the ability to change or update your plans in the future
- Does not affect your current finances in any way
- Allows you to make a greater impact than you likely could with a current gift
- May help you to reduce or avoid taxes

### A GIFT YOUR WILL

You can make a “bequest” to Action Against Hunger by including a gift in your will or trust. There are many options that you can choose from, such as:

- Setting aside a specific amount or asset,
- Giving a percentage of your overall estate, or
- Providing a portion of what remains after your debts, expenses and gifts to other beneficiaries are distributed.

With these options, you can provide for your loved ones while also helping us move closer to a world free from hunger. You may also save on income, capital gains or estate taxes.

### RECOMMENDED LANGUAGE

Simply bring this language to your attorney to include a gift to Action Against Hunger in your will or trust:

*“I give, devise and bequeath to Action Against Hunger, One Whitehall Street, 2nd Floor, New York, NY 10004, federal tax identification number 13-3327220, \_\_\_% of my residuary estate (or \$\_\_\_, or other property).”*

### A GIFT BY BENEFICIARY DESIGNATION

If you’re like most people, you have assets that allow you to name a beneficiary or successor to receive funds after your lifetime. Common examples include:

- Retirement plans, including Individual Retirement Accounts (IRAs)
- Transfer-on-death accounts
- Life insurance policies
- Donor-advised funds

You may be able to reduce income taxes for your loved ones by using this kind of asset to establish your legacy with Action Against Hunger. To make this gift, simply contact your plan administrator or account holder to request and complete a change of beneficiary form.
